Erick says that “ex-officio” means by virtue of the office. He asks if any of these members of the Personnel Committee hold any office, or if they are just additional, non-voting members.

Owen says that they are just non-voting members.

Erick asks for “ex-officio” to be changed to “non-voting.”

Owen says he will make that change.

- [BOARD BILL 4.03 - An Act to Approve the 2026 Elections Policies and Procedures](#)

Ashwin says they will start where they left off last week at Section 8, “Polls.” He reads the section aloud in its entirety.

Reaa explains that the changes made to Section 8, subsection H include clarification on election days campaigning locations. She explains that while candidates can’t campaign within 100 feet of any EAC polling booth, if candidates are at the location before the EAC arrives, then candidates can stay there. She says, however, if EAC has included that location in their polling schedule, candidates can’t campaign at that location during the listed hours. She explains that Section 8, subsection H, clause 3.a, states that any QR codes on campaigning materials can only lead to the EAC website and not to the ballot. She explains that this change is being made because any time someone scans a QR code to the ballot and then leaves the site, it counts their ballot even if they didn’t submit it. She adds that anyone found to be campaigning without EAC supplied materials will be charged with a minor violation. She explains a change made to Section 8, subsection H, clause 3.c, prohibits any candidate or campaign affiliate from handling a ballot without written or email consent from the student.

Nandana asks about Section 8, subsection H, clause 1. She asks if candidates are barred from campaigning at posted EAC polling locations at any time.

Reaa clarifies that candidates can campaign at EAC polling locations, but only when EAC is not there. She says if EAC were to poll in the quad from 12 pm – 2 pm, then candidates could campaign there before 12 pm or after 2 pm.

Nandana asks if that rule only applies to the locations EAC has pre-released.

Reaa says yes.

Kate asks about subsection H, clause 3.a. She asks if there is a clause in the EPP that states where the ballot must be on the EAC website.

Reaa says the ballot is always on the home page.

Ashwin says the Judicial Committee was wondering why the change to the QR code was made as well. He explains that SAO told them the change was made because of the issue with ballots being counted without them being filled out.

Nandana says since candidates have the voter link at their own tables, it is their freedom of speech to guide people directly to the ballot. She is concerned they do not have the right to tell candidates what link to provide.

Reaa says she asked SAO last year if EAC could provide a QR code that leads directly to the ballot, and they said no. She explains that the reason was because ballots were being incorrectly counted when people exit out of the ballot without filling it out.

Kate asks if she is right to assume that subsection H, clause 3.a, only applies to the packet that candidates receive from EAC, and 3.b applies to everything else. She says, to her, it seems the clauses prohibit a QR code leading directly to the ballot on any EAC materials, but it's not prohibiting candidates from providing a QR code directly to the ballot on their own individual materials.

Reaa says the ballot is either on the HuskyLink or the EAC website. She says that they have been advised by SAO to not use links that lead directly to the ballot.

Ashwin clarifies that this change makes it so there is no way for candidates to promote links that lead directly to the ballot.

Kate asks if that is physically true, due to the nature of the link, or if that is the EAC infringing on people's freedom of speech.

Reaa explains that it will count as a vote if someone opens a link leading directly to the ballot, even if they don't fill out the ballot. She says this has caused issues with voting.

Marshall says it is an issue with security.

Reaa says she isn't sure, because you have to log in with UW NetID no matter what link you use.

Nandana says she has typically ... She asks if this applies to all materials candidates give out. She says

Reaa says it would apply to all materials because any access to a link that leads straight to the ballot will inaccurately be counted as a vote.

Kate says her campaign last year used the link that led straight to the EAC website

Reaa says they can clip it, but SAO highly advised against it.

Peyton clarifies... so it doesn't make sense to add this to the EPP since there is no way at all to clip the ballot anyway.

Reaa says it makes sense to keep it in the EPP because...

Nandana asks the EAC what they think about removing this as a minor violation, and keeping it as something that is highly suggested

Reaa says they made it suggested and not required last year, and it did not help the issue at all as everyone still used a link that led straight to the ballot and not the EAC website

Ashwin says that the Judicial Committee did not have a comment on this being a minor violation. He asks if

Reaa

Peyton asks if the EAC will provide people with the same QR code to the EAC website to all candidates.

Reaa says the EAC can do that. She says that

Nandana asks if this is only applicable

Reaa says they won't include social media since that will be too difficult to control, but all physical campaigning will be obliged to follow this rule

Nandana asks why the last sentence has been removed from 3.b.

Reaa says 3.c. addresses... she says there were ballot issues last year, and that sentence has been removed to curb those issues. She explains that, yes, it makes it slightly less accessible, but...

Nandana says she recognizes that issue, but she doesn't see how the removal of that sentence solves this issue. She says it creates a weird... barrier and

Reaa says she understands that, but her only concern is that candidates could tamper with someone's ballot...

Kate explains that she doesn't understand why a form can't sit on the table letting people sign saying that they give consent to someone touching their phone.

Peyton asks if it is possible for the EAC to have a document that says what the steps are to vote to mitigate any issues voters have while at candidates tables.

Reaa says she created that document last year, and that is why she

Ashwin explains that Nandana's point makes sense, and because "assist" is such a broad term, it should be left in the EPP instead of being taken out. He says that it will save the Judicial Committee a lot of time...

Reaa explains that she would be open to adding... She suggests "talking"

Tammy explains that, while she understands wanting to give candidates good faith, this addresses EAC's concern about candidates interfering with ballot

Nandana explains that "assist" is generally a positive word, and taking this sentence out assumes that candidates will tamper with ballots. She says that this sentence assumes that candidates are assisting in good faith.

Reaa suggests

Nandana agrees.

Ashwin says that is why he added... He agrees that "assist" should be left in there.

Nandana

Ashwin says yes.

Ashwin says because of how broad "assisting" is so broad... then it is okay

Grace explains that she remembers the document that was sent out to all candidates... She recommends adding pictures to the document to lower the risk of a candidate being perceived as tampering with a ballot

Peyton suggests making it a requirement for all tabling candidates to have that document at their table. She explains that would allow for people

Ashwin agrees with Peyton's idea, but he says that the possibility of someone not wanting to... He says that there should be both mediums as an option on the table.

Nandana strongly recommends re-adding "assist in the voting process with consent." She asks if someone handles someone's ballot without consent

Reaa says it helps candidates when they have to come to the Judicial Committee

Nandana asks why consent isn't assumed unless

Reaa says she doesn't want to leave loopholes, and having the added rule makes it more fair and adds a safeguard

Nandana says it seems too regulated

Jessica clarifies if consent can be gained from...

Reaa says any consent other than verbal would probably be fine. She explains that it makes it easier for candidates to prove themselves in front of the Judicial Committee

Peyton says in most situations, you don't want to assume consent. She says this helps voters... She explains that while she would love to assume good intent, but there can be a scenario... she says that this makes it easier in the complaint process...

Owen explains that if this rule is too strict, it could place...

Ashwin says that is technically written consent, so yes.

Reaa says it will need a signature, so if it can be done on a phone, then that is okay. She says a printed page is ideal.

Khushi suggests a form...

Reaa says she isn't sure how they would track the violations...

Khushi says that is fair.
