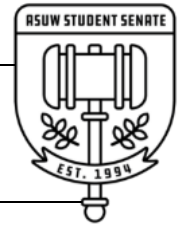

A Legislative Directive Supporting Joint Memorial 8014

Under Consideration - 2025-2026 Academic Year

BILL SUMMARY: Joint Memorial 8014 was submitted to the Washington State Senate with 13 sponsors to investigate the death of Aysenur Ezgi Eygi, a UW alumnus killed by an Israeli sniper in the occupied West Bank of Palestine. The ASUW cannot testify in favor of this bill without the passage of a Legislative Directive.

1 **WHEREAS** Aysenur Ezgi Eygi was a native Washingtonian, UW
2 alumnus, and American citizen who dedicated her life to the
3 dogged pursuit of the highest ideals of freedom and human rights
4 [1]; and

5 **WHEREAS** Eygi was tragically killed during a nonviolent protest
6 in the occupied West Bank of Palestine by an Israeli sniper on
7 September 6th, 2024 [1]; and

8 **WHEREAS** nearly a year and a half later, this killing remains
9 uninvestigated by the American government [1]; and

10 **WHEREAS** the Washington State Senate is currently considering
11 Senate Joint Memorial 8014, which would memorialize Eygi and
12 call upon the federal government to finally investigate her
13 death [1]; and

14 **WHEREAS** neither this bill nor Eygi were mentioned in the 2026
15 ASUW-OGR Legislative Agenda [2];

16 **THEREFORE, BE IT RESOLVED BY THE ASSOCIATED STUDENTS OF THE**
17 **UNIVERSITY OF WASHINGTON:**

18 **THAT** the Director of Legislative Affairs, Brandon Elliot, be
19 authorized to lobby on behalf of Joint Memorial 8014 during his
20 time in Olympia, including testifying on it; and

21 **THAT** this Legislative Directive be forwarded to Director of
22 Legislative Affairs Brandon Elliot upon passage.
