BOARD BILL 2.07: An Act to Amend the ASUW Volunteers Policy

- 1) WHEREAS: The Personnel Director and Vice President are responsible for handling all volunteer-related inquiries as outlined in the ASUW personnel policy;
- 2) WHEREAS: The ASUW Personnel Policy defines specific titles for volunteer positions to ensure consistency and clarity across the association;
- 3) WHEREAS: The current policy sets appointment and role requirements for interns and committee members;
- 4) WHEREAS: There is a need to clarify limits on intern positions within individual ASUW entities to ensure equitable distribution and sustainable management of volunteer opportunities;
- 5) WHEREAS: Entities may require exceptions to these limits based on operational needs, subject to executive approval;
- 6) WHEREAS: Interns may be required to represent their entity in university or ASUW meetings, ensuring appropriate oversight and accountability;

THEREFORE, BE IT ENACTED BY THE ASSOCIATED STUDENTS OF THE

UNIVERSITY OF WASHINGTON BOARD OF DIRECTORS:

- 1) THAT: The Personnel Policy, Section 13 | Volunteer Policy and Procedure, is amended to include the following: "No ASUW entity may appoint more than four interns per quarter, unless additional positions are approved by the President or Vice President."; and,
- 2) THAT: The Personnel Policy, Section 13 | Volunteer Policy and Procedure, is amended to include the following: "Responsibilities listed in each job description may not be delegated to interns. Interns may represent their entity at any internal or external meeting only when accompanied by an employee of the entity with the exception of sending an appointee to weekly Senate meetings after informing the Personnel Director and Vice President."; and,
- 3) THAT: All other provisions of the ASUW Volunteer Policy remain in effect.
- 4) THAT: Upon the approval from the Board of the Directors the ASUW President, Nandana Jaideep, shall forward this legislation to those listed below:
