NEW BUSINESS

RSO Funding

- Grace asks how much funding the RSOs have requested for this week. Khushi says she doesn't have the number off the top of her head but will get back

SAF Presentation

- Khushi walks through the presentation she gave to SAF for FY27 to highlight initiatives ASUW supports and how they support the student body
- Khushi highlights the reduction in the deficit and that benefit loads were not requested from SAF
- Khushi walks through wages and shows increases and decreases in funding requests
- Khushi walks through operational costs such as revenues and expenses

- Khushi explains that shared services were added to the FY27 budget and shows the committee
- Trevor walks through the general fund and clarifies the exact amount of money leftover in the fund
- Khushi explains that ASUW cannot budget out of the general fund including wages. The general fund is meant to act as an emergency fund.
- Grace asks if the Provost money is intended to be used for multiple years. Khushi says yes and it is recurring as of now

- Trevor asks if the benefit load was shown as an income. Khushi explains that it was listed as an expense in the budget packet

- Grace asks what the F&B committee will look like moving forward. Khushi explains that it will be a little light from now on and mainly focus on Special Appropriations Funding and programming ideas
