NEW BUSINESS

SAO Funding

- Khushi explains that this year the funding allocated was 90k, which was then bumped to 120K and most recently, 175K
- Khushi would like the F&B Committee to come to a consensus regarding final number for this year
- Khushi explains that next year, the starting amount for SAO Funding will be 120k
- Owen asks if the funding is distributed across quarters. Khushi answers yes.
- Khushi proposes that SAO funding stops a week from today.
- Kira proposes to increase funding to 200K as a cap and keeping it strict
- Owen suggests 200k as well and explains that the next F&B director can increase funding as needed
- Kimberly asks if the money would come from the general fund. Khushi says yes.
- Owen asks if it is possible to announce there will be 1-2 weeks left to apply for funding
- Trevor expresses concern about the timeline if the committee were to add money to the SAO Funding
- Khushi and Anushka propose a 190K fund total and to go from there as needed
- Kira asks about the backlog for funding. Trevor explains that there is about a 30 RSO backlog
